Medical

Doctor Degree (GMC 2018) – Consultation still open

The consultation on a draft Apprenticeship Standard for Doctor Degree (GMC 2018) is still available to complete until 12pm on Thursday, 16 September 2021.

This apprenticeship standard has taken the behaviours, skills, and knowledge from Outcomes for Graduates (GMC 2018) and is being developed by an employer led Trailblazer group that includes representation from the General Medical Council, the Medical Schools Council and Health Education England.

All Doctor apprentices will be required to complete a Degree in Medicine from a UK university permitted by the GMC to award Primary Medical Qualifications. Feedback will be reviewed following the closing date and the Trailblazer will consider where amendments should be made to the draft Standard. It expects to submit the Standard and End Point Assessment plan to the Institute for Apprenticeships and Technical Education in November 2021.

e-portfolio go-live for the Trainee Pharmacist Foundation Year Programme We recently announced the appointment of the Royal Pharmaceutical Society (RPS), in collaboration with Axia Digital, to deliver the new e-portfolio system for all trainee pharmacists in England for the 2021/2022 foundation year.

This e-portfolio will support the use of our <u>foundation year assessment strategy</u> (foundation year being the new name for the pre-registration year). The e-portfolio is now live! Enhanced Clinical Practitioner (ECP) apprenticeship scoping survey now open

Employers now have the opportunity to have their say on the scope of the Enhanced Clinical Practitioner (ECP) apprenticeship. This is a new apprenticeship standard to support employers to develop staff to enhanced levels of practice with specific knowledge and skills in a field of expertise.

To support the national uptake of the ECP Apprenticeship, HEE intends to develop guidance, support material, and undertake a national procurement to source both national and regional providers. To enable this, HEE are asking employers to indicate their future workforce demand alongside their views and suggestions for the use of the ECP apprenticeship.
