Message from Wendy Reid, HEE's interim Chief Executive

This <u>week's message</u> focuses on the importance of welcoming new students and trainees into the NHS offering them support and encouragement in an uncertain world - Being the role model we all would like to be is even more important this year. <u>Read the weekly message</u> here.

GP specialty training acceptances continues to break records – highest number ever seen in the NHS

After the initial rounds of recruitment, there have been 3441 acceptances for GP specialty training, the highest ever figure for this stage in the recruitment process, and the highest number of trainees entering GP specialty training that the NHS has ever seen at this point. This is up 15% from 2019 when there were 2891 acceptances. This has been an increase in numbers for the third year in a row.

HEE is still recruiting to GP this year and the next round opens at the end of this month. The final overall total for this year will be known in the autumn. The published Round 1 and Round 1A figures also highlight good increases in fill rates across other key specialties including, core psychiatry, which has seen a 100% fill rate. Postgraduate Medical and Dental Education (PGMDE)

The Healthcare Education Team (HET) can be contacted for any medical and dental trainee enquires via the <u>support portal</u> in the first instance. Trainees should be aware that the HET team are working hard to respond to queries, and that they should explore the FAQs available first to see whether their query has already been raised and addressed by someone else.

Quality

The KSS Quality Team recently sent out communications to stakeholders outlining plans to restart *routine* quality assurance and monitoring, in line with national HEE restart plans.

For KSS Trusts, this includes reviewing any paused quality interventions to determine whether these are appropriate for the current climate, working with Trusts to arrange virtual quality interventions only if required.

Outstanding action plan monitoring will commence from 1 September 2020.

A letter sent to Trusts also noted that the process for Training Site Approval During COVID process was under review; the revised process has been shared this week. The Training Site Approval During COVID letter and process can be viewed online here.

For Higher Education Institutions (HEIs), restart plans include a return to usual mechanisms for HEI *routine* reporting of concerns regarding the quality of clinical learning environments for healthcare students from 1 September 2020.

The routes to raise any concerns linked to Induction, Supervision, and Trainee/Patient safety for all students and learners remain in place via the escalating concerns process. All students, trainees, and learners have been informed on how they can raise any concerns related to their clinical learning environment via their professional/educational networks.

In the case of significant or urgent concerns which has not been possible to resolve using local or usual routes, trainees can contact HEE directly via the emerging concerns email for all learners on EscalatingConcerns.KSSQuality@hee.nhs.uk. This email inbox will be monitored closely by the senior dean team and should only be used where local resolution has not been possible.
