Joint statement on planned placements in England

HEE has <u>published a joint statement</u> along with the Council of Deans of Health, the Nursing and Midwifery Council (NMC), the Health and Care Professions Council (HCPC), and NHS Employers. This statement expands on the previous <u>NMC</u> and <u>HCPC</u> emergency measures to support the COVID-19 response and clarifies how planned placements for nursing, midwifery and allied health profession (AHP) students should be used.

Join the advanced practice conversation

HEE has launched an <u>online advanced practice workshop</u> to gain insights on the impact of COVID-19 and the implications for advanced clinical practice in the future.

The findings will enable HEE, NHS Employers, professional and representative bodies, regulators, and healthcare professionals to shape plans to support COVID-19 demands and people presenting with non-COVID-19 needs. The feedback will also shape the development, education, utilisation, and deployment of advanced practice.

HEE e-Learning for Healthcare (e-LfH) updates

This week the e-LfH COVID-19 e-learning programme reached the milestone of one million session launches since it went live in mid-March.

The e-LfH team has recently added the following to their COVID-19 programme:

- New resources for radiographers, the content includes minimising risk using PPE and infection control, how to safely use mobile equipment, and optimising image quality. The resources can be accessed here.

South east student placements

As part of the COVID-19 response, HEE south east has been working with NHS trusts and Higher Education Institutes to enable students to enter extended work placements. To date in the south east, almost 3,000 students have taken the opportunity to gain valuable experience and support the response to COVID-19. The students across the south east include 1,945 students across all fields of nursing, 422 midwifery students, and 598 AHP students.

We caught up with a Learning Disability (LD) Nursing student, Becky Boxall (pictured on the right) from Southern Health NHS Foundation Trust. Becky elected to take the optional extended placement in her final year of training to be an LD nurse and hopes to graduate in December 2020.

Becky said:

"I feel privileged to be working at Southern Health NHS Foundation Trust to help in response to the COVID-19 pandemic. It has given me such a valuable experience so that I can hit the ground running. I am treated just like a member of the team and love that the work is so varied, working in the community means that no two days are ever the same".

This email inbox will be monitored closely by the senior dean team and should only be used where local resolution has not been possible.
