Postgraduate Certificate in Human Factors and associated Masters programme

As part of HEE NE's Faculty of Patient Safety, we are again able to support a limited number of clinicians who wish to pursue the Postgraduate Certificate (PgC) in Human Factors that has been established at Teesside University (Postgraduate Certificate - Advancing Human Factors in Health and Social Care). Funding is also available for those who have successfully completed the PgC and wish to continue on to do a further year of study toward the associated Masters programme.

This builds upon the recent Human Factors Concordat from the National Quality Board, of which HEE is a signatory. It aims to provide individuals with an in-depth knowledge of human factors and improvement science. The PgC will require candidates to lead an improvement project that incorporates human factors principles in the delivery of healthcare within their Trust.

Interested candidates will need to submit the attached application form by the deadline of **9am Friday 5th August 2016**. The application should include an outline of the proposed improvement project, how it relates to your organisations existing priorities and work streams, and be achievable within a 24 week timeframe. It should be accompanied by a statement of support from your employer (e.g. Medical Director/Clinical Director/Director of Nursing) or Postgraduate dean confirming that you are in the position and have appropriate organisational support to bring about the identified improvements in delivery of healthcare within your workplace.

The PgC commences in October 2016 with preparation for/guidance on the chosen improvement project beginning at the induction day in September. Applicants should ensure they are available to attend the induction and relevant study block dates below.

HEE NE will part-fund the cost of fees up to £750 for successful applicants. The remaining balance of the study fee, and any additional travel/incidental costs, will need to be met by the individual.
