#### **Faculty of Advancing Clinical Practice**

The NHS Long-Term Plan calls for a step change in advancing practice, requiring capacity to be built at national, regional and local level – including STPs, ICSs or 'faculties' to drive change. HEE's National Centre for Advancing Practice has been established to standardise routes into advanced practice, accredit advanced practice programmes and recognise registered health and care practitioners who demonstrate the capabilities set out in the advancing practice or consultant practitioner framework and the national education standards for advancing practice.

The concept of a faculty at both regional and sub-regional level is a virtual hub and spoke model; based on strong co-production, co-ordination and extensive stakeholder engagement on all matters relating to advancing practice. The south west faculty will work with all partners at a regional and local level to ensure that the region supports the development of Advancing Practice as set out by the HEE National Centre for Advancing Practice and in a manner that is responsive to

# Interim foundation pharmacist programme: registration live

Registration for the interim foundation pharmacist programme is now <u>live</u>. This new education and training programme has been established to support the 2019/20 cohort of pre-registration pharmacists whose training and registration have been disrupted by the COVID-19 pandemic. It also provides a unique opportunity to accelerate <u>pharmacist early years' education and training reform</u> and supports delivery of the <u>NHS People Plan for 2020/21</u>.

This is a positive step towards delivering the recommendations from <u>HEE's Advancing Pharmacy Education and Training (APET)</u>, and meeting the ambitions of the <u>NHS Long Term Plan</u>, <u>NHS Interim People Plan</u> and <u>NHS People Plan for 2020/21</u>.

#### **New NHS Education Contract**

The new NHS Education Contract will be introduced from April 2021, to replace the varying contractual arrangements currently in place (including the Learning and Development Agreement with NHS service providers).

The NHS Education Contract will become a key tool for improving the quality of education and training, driving change, and providing funding. To help develop this new standard contract, HEE is seeking the advice of partners, especially those who use the Learning Development Agreement or may use the new NHS Education Contract in the future. HEE has begun work to identify what can, and should, be in any new contract and a draft contract document has been prepared for consideration. ### Toolkit outlines safe return to simulation training

A toolkit has been produced for learners to safely return to face-to-face simulation training. #### Flu Immunisation e-learning programme updated for the new season

The e-LfH programme has worked with Public Health England to update the Flu Immunisation e-learning programme to ensure it is up to date for the 2020/21 flu season.

With the ongoing global COVID-19 pandemic, it is more important than ever that this year's annual flu vaccination programme is safely and effectively delivered to as many of those eligible as possible to protect those at risk. It is therefore crucial that those giving flu vaccines are confident, competent and have up to date knowledge about the vaccine(s) they are giving. The Flu Immunisation e-learning resource is designed to provide all healthcare practitioners involved in delivering the national flu immunisation programme with the knowledge they need to confidently promote high uptake of flu vaccination and administer the flu vaccines to those who need them.
