

Strategic Support Fund Application Template and Guidance

Purpose

- 1. The Strategic Support Fund has been created exclusively to encourage the establishment of new courses for healthcare professions prioritised in the NHS Long Term Plan and People Plan, by funding the associated education infrastructure. The maximum value of any awarded funding over eighteen months is £100,000.

Eligibility pre-requisites

- 3. HEE will consider applications to fund infrastructure to support the establishment of new courses for the following healthcare professions:
 - Pre-registration nursing, in all four disciplines
 - General practice nursing
 - Diagnostic and therapeutic radiography
 - Occupational therapy
 - Orthoptics
 - Physiotherapy
 - Prosthetics and orthotics

- Nursing associate
- Midwifery
- Dietetics
- Operating department practice
- Paramedics
- Podiatry
- Speech and language therapy
- 4. Applications must be submitted in collaboration with local NHS placement providers, and be jointly endorsed by both organisations' vice-Chancellor / Chief Executive;
- 5. HEE will consider funding applications to develop infrastructure that supports the establishment of new courses, not for the expansion of existing courses. HEE will consider applications to fund infrastructure that supports the reopening of courses that have been discontinued for two years or longer (last intake in January 2018).
- 6. Applicants must be able to evidence their expenditure of awarded funding and be in a state of readiness to receive their first intake of new students by 1st October 2021 at the latest. Awarded funding will be repayable in full to HEE in the event that this condition is not met.
- 7. Higher scores will be given to those that can admit their first intake earlier (please refer to the Weighted Success Criteria below).

Application Evaluation

- 8. Applications will undergo an initial review by the corresponding HEE regional director (RD), including consideration of the feasibility of applications and to confirm they demonstrate an acceptable and appropriate use of public monies. The national panel will only consider applications that have been endorsed as feasible by the RD.
- 9. To enable a robust and fair process, the national panel will assess and score applications against the weighted criteria set out below. In the event of this process being over-subscribed, this will allow the highest ranked applications to be selected and also ensure that a minimum pre-set threshold is met, up to the maximum available aggregate funding of £2million.
