		Only minor changes have been made to the guidance in the 2023 to 2024 guidance where clarity has been requested by stakeholders or where paragraphs no longer apply.
2.11	2.13	A bullet point has been added to this section to clarify the criteria that must be met for a placement provider to be eligible for the postgraduate medical tariff.

2.11	2.13	The bullet point relating to workplace shadowing and assistantship has been updated. The guidance now confirms that the placement must not be a post-graduation assistantship in undergraduate medicine. Pre-graduation assistantship/activities are covered by the undergraduate medical (UGM) tariff.
NA – new	2.20 – 2.22	Three additional paragraphs have been added to the guidance to provide further detail about how the education and training tariffs support the provision of Knowledge and Library Services.

3.1	3.1	Table 1 within the 2023 to 2024 guidance confirms the updated prices for each of the tariff types from the 1st April 2023. For clarity, these updated prices are: Clinical = £5,193 plus MFF per full time equivalent (FTE)
		Medical Undergraduate = $\pounds$ 31,937 plus MFF Medical Postgraduate = $\pounds$ 12,398 plus MFF Dental Undergraduate = $\pounds$ 33,504 plus MFF
3.2	3.2	The link has been updated to the NHS England published market forces factor (MFF) figures for 2023 to 2024.

6.1	6.1 - 6.2	Confirms that the undergraduate dental (UGD) tariff price for 2023 to 2024 has been uplifted for inflation within the outcomes of the spending review.
		As the undergraduate dental tariff was only introduced from 1st September 2022, no further significant changes have been made in 2023 to 2024 to allow these changes to bed in.

6.6	6.5	Due to the introduction of the new Annex for undergraduate medical placements in PIVOs, the undergraduate dental annex is now Annex E.
