

The Oliver McGowan Mandatory Training on Learning Disability and Autism – conditions of delivery

- The Oliver McGowan Mandatory Training on Learning Disability and Autism may only be delivered by trainers who have been trained through an approved trainers' course and whose names are held on the NHS England list of approved trainers.
- Approved trainers will support, promote, champion and uphold the reputation of The Oliver McGowan Mandatory Training on Learning Disability and Autism at all times.
- Approved trainers will fulfil any approval and accreditation requirements.
- Approved trainers will co-operate with all investigations and audits.
- Approved trainers will respond to any complaints made against them in line with their organisation's policies and processes.
- Approved trainers may only deliver the standardised training packages which are subject to copyright.
- Trainers will regularly review the materials online to ensure they are using the most recent versions.
- All training and train the trainer courses must maintain fidelity to the delivery model; training materials may not be amended, removed or substituted without written permission from NHS England.
- NHS England grant approved trainers a non-exclusive, royalty-free licence to use the training materials and the registered trade mark relating to OM Oliver's Campaign.
- Approved trainers must not do anything which may prejudice the trade mark and shall immediately notify NHS England if they becomes aware of any actual, suspected or threatened infringement of the copyright subsisting in the training materials.
- Approved trainers shall promptly inform NHS England of any suspected unauthorised use of the trade mark relating to OM Oliver's Campaign and shall provide NHS England with such documents, information and assistance as it can in relation to any such use.
- Approved trainers agree that any intellectual property they

generate in carrying out The Oliver McGowan Mandatory Training on Learning Disability and Autism will be owned by NHS England and they will take all necessary steps to assign such rights to NHS England.

- Trainers will keep accurate records of trainers trained (and when) and submit these via the process determined by NHS England.
- Trainers will keep accurate records of participants who receive the training and submit these records to their employing organisation and to NHS England as requested.
- Trainers must adopt the standardised evaluation process and participate in any quality assurance / accreditation processes as and when these are introduced and as requested by NHS England.
- At all times trainers delivering The Oliver McGowan Mandatory Training must demonstrate the principles and values described in the [Core Capabilities Framework for Supporting People with a Learning Disability](#) (p17) and the values and behaviours described in the [Core Capabilities Framework for Supporting Autistic People](#) (p16).
- At all times trainers delivering The Oliver McGowan Mandatory Training must act and deliver training within their field of competence.
- It is expected that trainers deliver the training to a high standard. Should there be any cause for concern in the quality of training or if trainers are not complying with the conditions of delivery, appropriate measures will be employed to review and assure the quality of training. If required, this may mean approved trainer status is withdrawn.
